2. Following B-17 Repl Combat Crews are asgd Shipment FG-400-BA and WP fr Hunter Field, Ga, by rail to Camp Kilmer, N. J. so as to arrive 28 Mar 44 rptg to CG for temp duty pending further dispatch to overseas destination through New York Port of Embarkation.

c. This shipment will use APO 16007-BA (suffixed by individual crew no. to which asgd i.e. 16007-BA25) c/o Postmaster New York, N. Y. Upon arrival at overseas destination, pers will advise friends and relatives of their permanent APO and cable addresses by forwarding completed V-mail Change of address form (WD AGO Form 971).

d. Pers will be clothed and equipped in accordance with List C, Individual Clo and Equipment, 15 Nov 43, as modified by AAF ltr 65-4, 20 Jan 44 and as further modified by AAF ltr 370.5 (11 Mar 44) Shipment FE-400 11 Mar 44.

e. QM, Hunter Field, Ga, is designated shipping QM and will provide the necessary passenger and baggage cars for movement of pers and will also provide for proper installation of field ranges in kitchens.

f. UP WD Cir #341, 1943, QM will furnish in adv 1-1/3 days troop train rations plus 1/3 day additional troop train ration for delay enroute. Payment a/r 6¢ per ration (2¢ per meal) for purchase of ice and necessary articles of subs is authorized for the scheduled time plus amounts at the same rate for all additional rations or meals provided for delay enroute.

g. Maj JAMES M GRAYBEAL O399520 and Capt ROBERT MORGAN O434030, Crew FG-400-BA-68 are designated Provisional Gp Leaders. Capt WALLACE C CLINE O429604 is designated Provisional Group Leader and will accompany pers of this shipment to their overseas destination on temp duty and upon release by theatre commander, will ret continental United States and his proper sta MacDill Fld, Fla. O will travel with troops going and will ret by most expeditious means.

ANNEX "A"

The information contained in this annex constitutes an integral part of the atchd Special Order.

- (1) This is a PERMANENT change of station to an overseas destination.
- (2) Pers will not be accompanied by dependents, neither will dependents join personnel at any assembly point, staging area, airport or embarkation, or port of embarkation. Travel by privately owned conveyance is not authorized.
- (3) Except as may be necessary in the transaction of official business, individuals are prohibited from discussing their overseas destination even by shipment designator. Each O and EM will be indoctrinated in matters of security and censorship of all activities of the personnel under movement orders and will be prohibited from filing safe arrival telegrams with commercial agencies while enroute and at domestic or overseas destinations.
- (4) In lieu of subsistence, a flat per diem of \$7.00 is authorized for travel and for periods of temporary duty enroute to final destination for O and Flt O, in accordance with existing law and regulations. Payment of mileage is not authorized. Such times as individual is billeted and subsisted as outlined in WD Memo W35-2-42 dated 30 Sep 42, his per diem will be suspended.
- (5) A flat per diem of \$7.00 is authorized for EM for travel and for periods of temporary duty enroute to final destination in accordance with existing law and regulations, if travel is performed by air. For travel by rail and for periods of delay enroute to final destination, monetary alws in lieu of rations and quarters is prescribed in accordance with WD Bull #19, 1943.
- (6) From time of departure from continental United States until arrival at overseas permanent station, payment of per diem is authorized for a maximum of 45 days.
- (7) Provisions of Section V AIR-FOM (Second Edition) 1 Aug 43 file AG 370 56 (6 Aug 43) except as otherwise indicated in this order, are applicable to this movement and constitute an integral part of this order.
- (8) In addition to existing instructions requiring immunizations, personnel will be immunized against yellow fever, unless previously accomplished, at least 2 weeks prior to departure from continental United States.
- (9) Asgmt of single O without dependents to BOQ is terminated. Married O and Single O with dependents furnished shelter while at this sta. Pers will remain atchd Staging Project Det until departure.
